On or about September 20, 2002, at and in the County of Sacramento, State of California, defendant(s) PETER BONDARUK and PAVEL H KVITKO did commit a felony namely: a violation of Section 459 of the Penal Code of the State of California, Second Degree Commercial Burglary, in that said defendant did unlawfully enter a commercial building occupied by ARBAT EUROPEAN MARKET, located at 5500 WATT AVENUE, NORTH HIGHLANDS, with the intent to commit larceny and any felony.

CASE SUMMARY (Briefly establish the factual basis of the offense and defendant's guilt, including dates, times and the identity of principal witnesses.)

1905 Hrs on 9-20-2002(Friday) S-1, S-2, and S-3 where caught on the Victim Business Security Surveillance Video pulling into the parking lot and getting out a vehicle. The three suspects spoke at the rear of the car before S-3 got back into the car and backed it into a parking stall near the front door of the Victim business, while S-1 and S-2 entered the store each picking up a shopping hand basket as they did. S-1 and S-2 then filled each of there baskets while occasional conversing with each other. S-2 then approached the cashier who was also running the meat counter and set his basket on the floor while S-1 hovered near the front door. S-2 then asked the clerk for something at the opposite side of the counter and as the clerk moved away S-1 fled the store with his basket with out attempting to pay for it. At that time the RP saw what was happening and chased S-1 as he got back into the vehicle with S-3 and fled the scene. RP then attempted to detain S-2, but was unable to do so.

RP later identified S-2 and S-3 from photographic line-ups. S-1 is only know as Konstantin, and is still not positively identified.
