## **Final Case Summary**

On 08/14/2022, the Sacramento County Coroner's Office received a report of the decedent's death from Sacramento Metro Fire. As required by Government Code, Section 27491, an inquiry was made into the death. The decedent was removed to this office where an examination was performed by Kenny Su, M.D.. The cause of death was determined to be:

Hanging

Other Significant Conditions: None

The decedent was a 79-year-old male that died at his residence. On 08/14/2022, he was found hanging by a cable in his backyard. An investigation was completed which resulted in no concerns for suspicious circumstances or foul play.

Based on the circumstances and cause of death, the manner will be listed as Suicide.
